The present Complaint has been filed by the Complainant under Section 31 of the Real Estate (Regulation & Development) Act, 2016 (hereinafter referred to as the “RE(R&D)Act”) read with Rule 34(1) of the Telangana Real Estate (Regulation and Development) Rules, 2017 (hereinafter referred to as the “Rules”) seeking appropriate relief(s) against the Respondents.

2. It is the common case of all the Complainants that they booked respective residential flats in the said project under separate Memoranda of Understanding executed in September–October, 2021, agreed to a sale consideration of ₹3,800/- per sq. ft., and paid 25% of the consideration as advance amounts to the Respondents, with an assurance that the project would be completed and possession would be delivered within 24 months with a grace period of six months.

3. The Complainants allege that even after expiry of the stipulated period, no development or construction activity has been commenced at the site and that the land forming part of the project has subsequently been sold to a third party, thereby giving rise to the present complaints seeking refund of the amounts paid along with interest and other consequential reliefs.

4. The present batch of complaints was initially listed before the Telangana Real Estate Regulatory Authority on 18.09.2025, on which date the Complainants as well as Respondents No. 3 and 4 were present and Respondent 1 and 2 were absent.

5. Thereafter, the matters were listed on several occasions from time to time from 27.11.2025 to 27.02.2026. While so, despite repeated opportunities being granted, the parties failed to appear and prosecute the complaints diligently. On multiple dates of hearing, either one or both parties remained absent, without any representation or request for adjournment.

6. On 22.01.2026, only the Complainant in CC No. 529 of 2025 was present, while the Complainants in the remaining matters and all the Respondents therein remained absent.

7. The matters were finally posted to 27.02.2026. On the said date, when the matters were taken up, both the Complainants and the Respondents remained absent. In view of the repeated non-appearance of the parties, the complaints are liable to be dismissed for non-prosecution.

8. Therefore, this Authority is of the considered view that even after affording of number of opportunities, the Complainants and the Respondents failed to appear and prosecute their case diligently before this Authority. Given the Complainant's consistent absence, it is apparent that they do not seek to pursue the matter. In lieu thereof, the present Complaints stands dismissed for non-prosecution.
